Featured News

The International Day of the World's Indigenous People was commemorated on 9th August. On this day, indigenous peoples' contribution to environmental protection was also recognized. In caring for the environment, UNEP has long considered indigenous peoples as important stakeholders and actively seeks to cooperate closely with indigenous peoples in the pursuance of its mission of 'environment for development'. For example, UNEP has recently launched the Indigenous Knowledge in Africa (IK) web site, a web-enabled database containing information on indigenous practices for the sustainable use of natural resources in Africa.

In recognition of indigenous peoples' particular vulnerability to climate change and their important role in responding to it, the UN Permanent Forum on Indigenous Issues in its 2008 session will focus on "Climate change, bio-cultural diversity and livelihoods: the stewardship role of indigenous peoples and new challenges".

The Critical Ecosystem Partnership Fund (CEPF) has recently announced a \$50 Million expansion. This expansion comes as the French Development Agency (AFD) committed \$25 million to CEPF, thus becoming its sixth partner. In addition, Conservation International (CI), agreed to match the AFD commitment dollar-for-dollar. CEPF provides grants for nongovernmental groups and private sector partners to help protect Earth's biodiversity hotspots, while empowering local people in the management of natural resources. CEPF is a joint initiative of Conservation International, l'Agence Française de Développement, the Global Environment Facility, the Government of Japan, the John D. and Catherine T. MacArthur Foundation, and the World Bank.

News from Members

Wetlands International: In July 2007 Wetlands International announced that the Dutch Ministry of Development Cooperation (DGIS) will support its major Wetlands and Livelihoods Programme (WLP). This programme will run from 2007 through 2010 and will build on the results of the Wetlands and Poverty Reduction Project (WPRP). The WLP will support the wetland and biodiversity conservation sector, the development aid sector and particularly also the private sector to cooperate in addressing poverty-environment and livelihood-environment issues in wetland areas. In this way it will contribute to the achievement of the Millennium Development Goals, in particularly goal 1 (halving poverty), 7 (environmental sustainability) and 8 (partnerships).

Featured Initiative

Poverty and Environment Initiative (PEI): In 2005 UNDP and UNEP formed a global partnership by merging their poverty-environment programmes into one integrated programme - the UNDP/UNEP Poverty and Environment Initiative (PEI). The core focus of PEI is to support country-led efforts to integrate the environmental concerns of poor and vulnerable groups into policy and planning processes for poverty reduction and pro-poor growth.

Building on the continued focus at the international level on poverty-environment mainstreaming, UNDP and UNEP have produced a proposal in April 2007 for scaling-up the Poverty-Environment Initiative. The overall aim of this proposal is to support a significantly larger number of countries to prepare and implement sustained country-led environmental mainstreaming processes, and to tackle the institutional and capacity development challenges of maximizing the contribution of environment to poverty reduction, growth and achievement of the MDGs.

The PEI is now financed by the Poverty and Environment Facility. The Poverty and Environment Facility was jointly launched on 6 th February 2007 by UNEP and UNDP in an effort to fortify their partnership. The facility is one of the first concrete examples of UN reform and will help developing countries integrate sound environment management into their poverty reduction and growth policies.
