## Secretariat News

**Biodiversity for Poverty Reduction at the CBD Cop9:** In place of a symposium this year, the PCLG will host a "Biodiversity for Poverty Reduction Day" to be held on Saturday May 24th – the middle weekend of CoP9 of the Convention on Biological Diversity - in Bonn, Germany. The day will have three key elements:

- 1) Policy initiatives linking biodiversity conservation and poverty reduction: this will highlight efforts to mainstream biodiversity in international and national poverty reduction policy and vice versa.
- 2) Research findings: what have we learnt about biodiversity-poverty linkages? This stream will highlight new research findings, drawing in particular on major global research initiatives
- 3) Linking poverty and conservation in practice: This stream will highlight the work of organisations who are exploring poverty-conservation links at the field level.

We would like to encourage wide participation in this event – from PCLG members and others. The event will present a great opportunity for networking and for finding out who is doing what on conservation-poverty linkages. If you would like to highlight your work (we will include a mix of paper and poster presentations) please send a short proposal including an abstract to [pclg@iied.org](mailto:pclg@iied.org) by 18th April 2008. We have a limited number of travel grants available. Any PCLG members in developing countries who are not otherwise attending CoP9 and might require assistance with travel expenses to attend this event should also contact us by 18th April.

## Featured News

### Working Group on Protected Areas of the Convention on Biodiversity, Rome, February 2008:

Dilys Roe, PCLG coordinator, attended the Ad Hoc Working Group on Protected Areas meeting in Rome from 11-15th February. PCLG provided co-sponsorship, along with Care, The Nature Conservancy and TILCEPA, for a side event exploring the social impacts of protected areas and methodologies to assess these impacts. A follow up workshop is planned drawing on practitioners experience to further develop widely applicable impact assessment tools and methodologies. Also at the meeting, recognising some ongoing tensions between indigenous organisations and conservation NGOs, a dialogue process was initiated – facilitated by TILCEPA – which will continue at CoP9.

One of the recommendations coming out of the formal sessions of the meeting was a recommendation that CoP9 "encourages Parties to ensure that conservation and development activities in the context of Protected Areas contribute to the eradication of poverty, to sustainable development and ensure

that benefits are equitably shared.” We will track the progress of this recommendation at CoP9. One of the less fortunate outcomes was that the International Indigenous Forum on Biodiversity decided to withdraw from the meeting as a result of feeling they were not able to participate effectively. **Chairman's Report: The Trondheim/UN Conference on Ecosystems and People – Biodiversity for Development – The Road to 2010 and Beyond, by Schei, P., 2007, Trondheim Conference on Biodiversity 2007**

This Chairman's Report provides a useful summary of the main discussions that took place during the fifth Trondheim conference, in November 2007. The meeting focused on the relationship between biodiversity, ecosystem services and people - and in particular on trying to understand the synergies and tradeoffs between conservation and development.

**Good Practices from the Natureandpoverty\* Programme, by Natureandpoverty\* Programme, 2007, 73 pp.**

This booklet contains brief descriptions of selected good practices that best illustrate the intervention strategies adopted in the natureandpoverty\* programme. It has been compiled to help those working for nature conservation and poverty reduction to share experiences, and to stimulate debate on good practices for poverty alleviation through sustainable ecosystems management.

This editorial introduces an issue of Biotropica dedicated to the persistent tension

between different approaches to conservation, particularly between approaches that emphasize the protection of biodiversity against conservation in support of human wellbeing.

The paper also includes outstanding issues, like the recognition of rights, participation, social cost of conservation, financing PAs, prioritization of the Programme of Work on PA and the emerging threats.
