PCLG at CBD COP 10: As you all know, the tenth meeting of the Conference of the Parties to the Convention on Biological Diversity (COP 10) will be held in Nagoya, Japan from 18-29 of October 2010. Featured News

UN and Oxford University unveil a new index to measure poverty: The United Nations Development Programme (UNDP) and Oxford University launched in July a new index to measure poverty levels, which they said gives a "multidimensional" picture of people living in hardship, and could help target development resources more effectively. The new measure, the Multidimensional Poverty Index, or MPI, was developed and applied by the Oxford Poverty and Human Development Initiative (OPHI) with UNDP support. It will be featured in the forthcoming 20th anniversary edition of the UNDP Human Development Report, and replaces the Human Poverty Index, which had been included in these reports since 1997. This year's Human Development Report will be published in late October, but research findings from the MPI are already available online on the websites of OPHI (<http://www.ophi.org.uk>) and the UNDP Human Development Report (<http://hdr.undp.org/en/>). **Ford Foundation Commits \$85 Million to Advance Rural Land Rights and Reduce Climate Change:** In July the Ford Foundation announced a five-year, \$85 million initiative that will make rural and indigenous people a stronger part of the world's response to climate change, saying that engaging these populations is essential to reducing poverty and building long-term climate solutions. Focused on six key regions, the initiative will empower rural communities whose livelihoods depend on natural resources to play a more active role in the stewardship of those resources. The foundation will also work with the global organizations, multilateral funders and governments that are set to invest billions of dollars over the coming years in climate change programs that will affect these communities. "We believe that the work we are supporting demonstrates a critical new paradigm: What's good for rural and indigenous communities is also good for the economy, the environment, and the world," said David Kaimowitz, the foundation's director of Sustainable Development. "We want to ensure that the lessons and promise of that work are understood and utilized by global policymakers, governments and other leaders."

Blue Ventures is one of 12 finalists competing for this year's prestigious World Challenge award, an international competition organised by BBC World News and Newsweek magazine to champion projects showing enterprise and innovation at a grassroots level. The judges selected the finalists from over 800 nominations, recognising Blue Ventures' work in Madagascar as a powerful demonstration that social enterprise can be an effective engine for developing sustainable conservation initiatives. Blue Ventures' work will be featured on BBC World News television and in Newsweek magazine. The winner of World Challenge 2010 will be announced at a ceremony in The Hague in December, and will receive a US\$20,000 grant from Shell to invest in their work. BirdLife: A new report, "**Partners for Sustainability – What BirdLife is doing for People and the Planet**", highlights BirdLife's work around the world that combines biodiversity conservation with sustainable development. There is a growing consensus that the international community will be much more likely to meet objectives like reducing poverty and improving health, wellbeing and resilience to climate change if we give biodiversity and ecosystem services the priority they deserve. Partners for Sustainability describes how BirdLife is working locally, nationally and globally, with communities, governments, international bodies and the public and private sectors, to create the environmental conditions for sustainable development.

The **2010 Biodiversity Indicators Partnership (2010 BIP)** brings together over 40 organizations and a suite of biodiversity indicators, allowing for a more comprehensive and consistent monitoring and assessment of global biodiversity, with a view to measuring progress towards the CBD's target to reduce the rate of biodiversity loss by 2010. The 2010 BIP Secretariat is currently carrying out its second **User Needs Survey** and would be very grateful if you could spare a few minutes to complete it. The Survey examines the background potential users of 2010 BIP outputs, and their preferences for 2010 BIP outputs. STEPS Conference 2010: Pathways to Sustainability: The conference “Pathways to Sustainability: Agendas for a new politics of environment, development and social justice”, which will take place on **23rd-24th September 2010 at the Institute of Development Studies, Sussex University, Brighton (UK)**, will explore how to conceptualise and build ‘pathways’ that link environmental integrity and social justice, while alleviating poverty and inequity. The five themes of the conference are: contesting sustainabilities; framing narratives; dynamics and sustainability; uncertainty, ambiguity and surprise; pathway building and governance.

12th Annual BIOECON Conference: Fondazione Eni Enrico Mattei, in association with Conservation International and the United Nations Environment Programme, announces the Twelfth International BIOECON Conference “From the Wealth of Nations to the Wealth of Nature: Rethinking Economic Growth”. The Conference will be held at the **Centro Culturale Don Orione Artigianelli, Venice, Italy, on September 27th-28th, 2010**. The central theme will focus on the identification of the most effective and efficient instruments for biodiversity conservation, such as auctions of biodiversity conservation contracts, payment-for-services contracts, taxes, tradable permits, voluntary mechanisms and straightforward command and control measures. Special attention will be given to the role of public bodies/NGOs in the creation of innovative mechanisms for the delivery of ecosystem benefits and in promoting the participation of a wider range of economic agents in biodiversity conservation.

Tenth meeting of the Conference of the Parties to the Convention on Biological Diversity - CBD COP 10: The tenth meeting of the Conference of the Parties to the Convention on Biological Diversity (COP 10) will be held in **Nagoya, Japan on 8th-29th of October 2010**. This meeting is expected to assess achievement of the 2010 target to reduce significantly the rate of biodiversity loss, adopt an international regime on access and benefit-sharing and celebrate the International Year of Biodiversity 2010.

CEESP Sharing Power Conference: The conference 'Sharing Power: A New Vision for Development' will take place on **10th - 15th January 2011 in Whakatāne, New Zealand**. The Conference focuses on the need for policy and decision makers in Governments and Corporations to accommodate a greater level of inclusion of indigenous peoples and all citizens, in national and international policies on the management and governance of bio-cultural resources, and advocates the rights of mother earth - the planet. New Publications in our database

Manejo Comunitario de Vicuñas en Perú: Estudio de Caso del Manejo Comunitario de Vida Silvestre, by Lichtenstein, G., Oribe, F., Grieg-Gran, M., Mazzucchelli, S., 2002, Poverty, Inequality, and the Environment No2, IIED, UK, 90 pp.: This study forms part of IIED's Evaluating Eden project, which explores community-based wildlife management (CWM) through a comprehensive review of initiatives worldwide, the aim being to assess what CWM has achieved for wildlife and for people and to identify the social, political, economic and environmental factors that influence its efficacy. Vicuna management in Peru was chosen as a case study because of the moves to give Andean communities more rights over these wild animals and the Government initiatives to promote sustainable use.

Manejo de Vicuñas en Cautiverio: El modelo de criaderos del CEA INTA (Argentina), by Lichtenstein, G., 2006, Investigación, conservación y manejo de vicuñas, Proyecto MACS, Universidad Nacional de Lujan., pp. 133-146.: Argentina is the pioneer country for vicuna captive breeding. The model was developed by the National Institute of Agriculture and Cattle Technology (INTA) at their High Altitude Experimental Station (CEA) with the aims of improving the economic situation of local people while contributing towards vicuna conservation. The lessons learnt from this system could be applied to other captive management systems.

Retórica y Praxis de la Participación Local en los Proyectos de Manejo de Vicuñas, by Lichtenstein, G., Renaudeau d'Arc, N., 2008, Cuadernos XXI del Instituto de Antropología y Pensamiento Latinoamericano, Vol 21, pp. 133-141: This paper explores the rhetoric and praxis of local participation in conservation and development projects using vicuna use by Andean communities as a case study. It concludes that most of the projects have failed to link participation with a process of empowerment of local people.

Vicuña Conservation and Poverty Alleviation? Andean Communities and International Fibre Markets, Lichtenstein, G., February 2010, International Journal of the Commons, Vol 4 No 1, Igitur, Utrecht Publishing & Archiving Services for IASC, pp. 100–121: This paper explores multiple-objective projects that address vicuña conservation and poverty alleviation in Andean countries. In doing so, it analyses the tensions that exist between these objectives, as well as the factors that limit a more equitable distribution of benefits among stakeholders.

RSG's are available to individuals and small groups. Applications can be made at any time of the year; decisions are usually made within three months. RSGs generally support projects of about a year's duration. Applications from non-first world areas are strongly encouraged. International Foundation for Science Research Grants: Applications for IFS Research Grants are welcome from young scientists in developing countries to do research on the sustainable management, use or conservation of biological or water resources. This includes natural science and social science research on agriculture, soils, animal production, food science, forestry, agroforestry, aquatic resources, water resources, etc. Applications are accepted all year.

Call for papers: Environmental Conservation is producing a themed issue on "Payment for Ecosystem Services in Conservation: Performance and Prospects". The purpose of this issue is to strengthen the evidence-base through a collection of papers addressing diverse aspects of the performance of payments for ecosystem services in environmental conservation. Papers may take the form of case studies of individual schemes, comparative studies, or thematic or geographical reviews. The editors will prioritize strong empirical studies.
