Featured News

The Norwegian government has announced support for developing countries input into the study known as TEEB, The Economics of Ecosystems and Biodiversity: The announcement was made at the beginning of September 2009 at the high level meeting: "Visions for Biodiversity Beyond 2010", in Stromstad, Sweden, by Erik Solheim, the Norwegian Minister for Environment and International Development. Speaking at the meeting in Stromstad, TEEB study leader Pavan Sukhdev said that biodiversity and ecosystem services have a vital role to play in climate change and mitigation and must be considered as part of the Copenhagen discussions in December. He also illustrated how effective decision-making with regards to the environment will have direct benefits to those living in developing countries. The final TEEB report will be issued in October 2010. In November 2009 TEEB

will release a report for national and international policymakers in order to engage more countries in dialogue for the final output in 2010.

News from PCLG Members

The Amazon Livelihood and Environment Network (RAVA): The Amazon Livelihood and Environment Network (known as 'RAVA', its Spanish acronym), was formed in 2007 by the World Agroforestry Centre (ICRAF) and other partner institutions within the Amazon Initiative (AI) Consortium (including CIFOR). Using the PEN methodology, RAVA analyses the living conditions of Amazonian communities to gain a better understanding of the impact of forestry, agroforestry and agricultural activities on the wellbeing of the communities and on the integrity of their surrounding environment. RAVA studies have been carried out across 14 sites in seven Amazonian countries. A database comprising information from a total of 2200 households in almost 150 communities is currently being assembled through the integration of data from the 14 surveys. REDD+ Social & Environmental Standards: This initiative is developing standards that can be used by governments, NGOs, financing agencies and other stakeholders to design and implement REDD and other forest carbon programs that respect the rights of Indigenous Peoples and local communities and generate significant social and biodiversity co-benefits. These standards are being designed to work for the new global REDD+ regime expected to emerge out of ongoing climate change negotiations. The standards are being developed through an inclusive process engaging governments, non-governmental organizations and other civil society organizations, Indigenous Peoples organizations, international policy and research institutions and the private sector. The standards' development is being overseen by a Standards Committee and facilitated by the Climate, Community & Biodiversity Alliance (CCBA) and CARE International. A draft version of the REDD+ Social & Environmental Standards is available in English, Spanish and French at <http://www.climate-standards.org/REDD%2B> and comments are invited until **30 November 2009**.

Because of the focus on environmental change, the meeting will highlight the importance of multidisciplinary and interdisciplinary approaches to conservation.

Tenth meeting of the Conference of the Parties to the Convention on Biological Diversity - CBD

COP 10: The tenth meeting of the Conference of the Parties to the Convention on Biological Diversity (COP 10) will be held in **Nagoya, Japan on 8-29 of October 2010**. This meeting is expected to assess achievement of the 2010 target to reduce significantly the rate of biodiversity loss, adopt an international regime on access and benefit-sharing and celebrate the International Year of Biodiversity 2010.

New Publications in our database

Human Nature, by Dowie, M., May 2009, Guernica: Is modern conservation linked with ethnic cleansing? In this article, the author explores the concepts of wilderness and nature, and argues that the removal of aboriginal human beings from their homeland to create a commodified wilderness is a deliberate charade.

Community Action to Conserve Biodiversity: Linking Biodiversity Conservation with Poverty Reduction, by GEF Small Grants Programme, UNDP Equator Initiative, March 2006, GEF Small Grants Programme and UNDP Equator Initiative, 76 pp.: In this report, launched in March 2006 at the eighth meeting of the Conference of the Parties to the Convention on Biological Diversity (COP 8) in Brazil, the SGP and the Equator Initiative collaboratively present thirty case studies from their portfolio to document and draw preliminary lessons from the successes of community-based biodiversity enterprises. While these cases are selected from across Latin America and the Caribbean and initially emerged from an international workshop in Merida, Mexico, they offer valuable lessons for a global agenda.

A Gateway to PES: Using Payments for Ecosystem Services for Livelihoods and Landscapes, by Huberman, D., 2008, Series No. 1, Forest Conservation Programme, IUCN, Gland, 37 pp.: The Gateway offers an introduction and sense of direction into the complicated world of payments for ecosystem services (PES). It is tailored for researchers, practitioners and decision makers interested in using economic incentives in support of conservation and poverty reduction efforts in tropical forests.

Systematic Approaches to Livelihoods Enhancement and Diversification: A Review of Global Experiences, by IMM, March 2008, IUCN, Gland, and Colombo; CORDIO, Kalmar; and ICRAN, Cambridge, 38 pp.: The Coral Reefs and Livelihoods Initiative (CORALI) aims to develop and test a systematic approach to Sustainable Livelihood Enhancement and Diversification (SLED) that builds on past experience and lessons from around the world. This Global Overview aims to bring together some of this global experience and provide guidance on how SLED might be further developed and used. It does not claim to be exhaustive, but rather an attempt to outline the subject and bring together key strands of understanding and learning.

Call for proposals for the 24th International Congress for Conservation Biology (ICCB): The call for proposals for symposia, workshops, discussion groups, and short courses for the 24th International Congress for Conservation Biology (ICCB) – to be held in Edmonton, Alberta, Canada on July 3-7, 2010 - is now open, and the deadline is October 14th. The call for individual abstracts (for oral or poster presentations) opens on October 7th, with a January 20th deadline. The theme of the meeting is "Conservation for a Changing Planet." Contributions from all fields of conservation research and practice are welcome, including natural sciences, social sciences, and humanities. The SCB's Social Science Working Group (SSWG) is making particular efforts to encourage social scientists to consider this invitation, in the hope of widening SCB's international network of social and policy researchers who are doing work in applied conservation. The CLP aims to promote the development of emerging conservation leaders and equip them with the capacity to address the most pressing conservation issues of our time. They do this by providing small grants, training, mentoring and networking opportunities, where award winners gain practical skills and experience and develop leadership capabilities through the implementation of projects focused on high-priority biodiversity conservation issues. The application deadline is 6th November 2009 for all applications, and awards will be announced in March 2010. MPhil in Conservation Leadership Launched: The new MPhil degree in Conservation Leadership is a full-time, one-year, masters course, aimed at graduates with five or more years of experience in conservation. The unique feature of this course will be its delivery by a partnership between several university departments and conservation organizations based around Cambridge, UK. The course will admit its first students in October 2010. The course is based in the University of Cambridge Department of Geography, which is working in collaboration with partners in the Cambridge Conservation Initiative (CCI) to deliver the course.
